Session 4

The Neuropsychiatry of TBI and Pregnancy

Traumatic Brain Injury (TBI) and pregnancy individually present complex neuropsychiatric challenges, but their intersection remains underexplored. This talk synthesizes current knowledge on the neuropsychiatric implications of TBI during pregnancy. TBI, characterised by cognitive, emotional, and behavioural impairments, can complicate pregnancy outcomes due to altered neurophysiology, increased stress, and impaired cognitive function. Pregnant women with a history of TBI face heightened risks of mood disorders, anxiety, and cognitive deficits, potentially affecting maternal and foetal health. Neuroinflammation, hormonal fluctuations, and stress response alterations post-TBI can exacerbate psychiatric symptoms, complicating management during pregnancy. Additionally, medication use for TBI-related neuropsychiatric symptoms requires careful consideration to avoid teratogenic risks. Multidisciplinary care, involving neuropsychiatrists, obstetricians, and rehabilitation specialists, is essential for optimising outcomes. Early identification and intervention strategies, including cognitive-behavioral therapy and tailored pharmacotherapy, can mitigate risks. Understanding the neuropsychiatry of TBI and pregnancy is crucial for developing comprehensive care protocols, ultimately improving the quality of life for affected women and their offspring.

Session 5

Bumps to Babies - Considerations for Case Management

Vicky Moss will cover risk screening to identify areas of need and risk, supporting case management planning and intervention, and considering which other professionals may need to be involved. She will also introduce tools for discussions with clients and families to ensure support is client-centered, reflecting the wishes, values, and cultural considerations of both client and family regarding pregnancy and childcare. The session will then address case management planning elements, including different options for childcare support, such as maternity nurse vs. nanny, live-in vs. live-out support, and the roles of a nanny vs. a childminder, along with considerations around each. Themes will include mental capacity, mental health, physical needs, executive functioning, fatigue, sensory issues, and cultural considerations.

Session 6

Exceptional Neuroplasticity of Parenthood

Alicia will share her recovery journey after a 2011 bicycle accident, highlighting how her pregnancies and the births of her two children significantly aided her healing through neuroplasticity. She will place special emphasis on the “sticky” stigmas surrounding both Motherhood and Traumatic Brain Injury (TBI). Alicia will delve into the systemic barriers faced by female neurotrauma survivors, particularly focusing on fertility risks, the stigma around motherhood, and behavioural challenges. Drawing from personal experience, she will discuss the challenges women face when managing neurotrauma while wanting or having children and offer insights into effective therapies that have helped manage chronic symptoms. Additionally, she will touch on how ‘Nurtured Parenting Training’ principles can be applied to neurotrauma recovery.

Dr Michael Dilley

Consultant Neuropsychiatrist, King's College Hospital NHS Foundation Trust and Brain & Mind Ltd

Mike, has a special interest in brain injury and severe and complex functional neurological disorder that requires interdisciplinary inpatient or day patient rehabilitation and outpatient treatment.

He provides input across the entire integrated care pathway for patients with neuropsychiatric needs associated with brain injury at King's. As such, Mike will often support a person's recovery along their entire journey from acute care to a return to the community.

He is a member of the Clinical Reference Group in Rehabilitation, Disability & Spinal Cord Injury at NHS England and Chair of the Faculty of Neuropsychiatry, Royal College of Psychiatrists. Mike is also a Trustee of the United Kingdom Brain Injury Forum (UKABIF). His previous roles have included leading the inpatient mental health services in Westminster, the national neuropsychiatry unit at The Maudsley, on the brain injury unit at St George's Hospital, the rehabilitation units at Putney and Blackheath and as Clinical Director of the NHSE London Neurosciences Network. Mike has worked extensively across organisational networks both locally, regionally and nationally in integrating mental health services for people with neurological conditions as well as in teaching and training about neurobehavioural rehabilitation and neuropsychiatric treatment.

Mike completed his training at King's College London, The Maudsley, National Hospital for Neurology & Neurosurgery, Institute of Psychiatry and The University of Birmingham. He is currently a co-investigator in the NIHR funded randomised trial of primary prevention of depression after traumatic brain injury.



Victoria Moss

Consultant Case Manager with North Star Case Management Ltd | Associate Care Expert Witness and Mental Capacity Assessor with Circle Case Management Ltd

Victoria Moss is a skilled social worker with many years experience of working with children and adults with complex needs including those with brain injuries, cerebral palsy, autism, epilepsy and other neurological conditions.

Following her qualification Victoria worked within a Local Authority as a social worker, initially a Children's Disability Team and then specialising to a Children's Disability Unit. This role involved completing child and family assessments in relation to care and support needs as well as the wider family needs and setting SMART goals for children and families. It involved multi-disciplinary working with statutory and independent therapists, nurses, doctors, teachers and school/ college staff and chairing regular multidisciplinary team meetings. Many of the children had complex needs and health conditions, including a number of children with life limiting conditions. The role also involved high-level safeguarding and undertaking Child Protection Assessments in partnership with the Police. Victoria has also completed the 5-day Safeguarding Children Investigation Training Course to lead Section 47 Child Protection investigations and assessments. Within this role Victoria also produced reports for the Family Courts and attended court to provide evidence.

Since 2014 Victoria has worked as a case manager with children, young people and adults with brain injuries and other complex needs. She works with clients with a wide range of needs. Her particular areas of interest include clients with issues with executive functioning and frontal lobe injuries, those presenting with behaviours which can be challenging to manage and mental health issues. She works in a very holistic and client centred way and takes a systemic approach to her assessments, case management planning and goal setting. Victoria is empathetic and compassionate in her approach to working with clients and families.

Victoria has significant experience of directly recruiting and managing care and support teams, including 2:1 24/7 packages of care. She is also very experienced at commissioning and coordinating a variety of services including agency care, maternity nurses/ nannies, private and statutory therapists, educational and vocational services to ensure that her client's needs are holistically supported. Victoria is also experienced in assessing mental capacity and providing reports in documenting her findings as well as completing COP3 forms.

Alicia Eastes

Neurotrauma Survivor, Woman in Film and Founder of WIFT Austin, Writer/Director/Producer at Looking Glass Media, LLC

Alicia Eastes is a young mother sharing her lived experience of the remarkable power of her reproductive capacity to transform her internal neurological experience of self again, after Neurotrauma, through motherhood. Alicia followed her biological instincts urging her to become a mother, defiantly, after a severe head injury in a bike accident and 13-day coma while she was in grad school studying screenwriting at UT Austin, in September 2011. After the accident, her periods changed, and she knew it was connected to her head injury, but could find no medical confirmation of this fearful threat to her fertility. In summer 2015, she completed a 30-day yoga challenge to get her periods back, and instead, she got pregnant. Every day of her pregnancy she felt better and better, and more like herself, as she remembers before her accident. This profound transformation of healing inspired her to investigate the science of this miracle in her feature documentary film, **"Liminal Space."**

Mark began working with individuals with an acquired brain injury in 1991 and has both supported brain injured people to parent, and given expert opinion on the matter; he is an author of an academic article on the subject.

Mark is the author of a number of peer reviewed academic articles relating to brain injury and service use, as well as book chapters and a book on the family experience of brain injury. He is an Advanced Member and Fellow of British Association of Brain Injury Case Managers (BABICM), the former Chair of the BABICM Training and Education Sub-Group and former elected member of the BABICM Council, a member of the National Institute of Clinical Excellence guidelines writing committee for neurorehabilitation, a former member of the National Institute of Clinical Excellence guidelines writing committee for supported decision making, and a member of the BABICM research group. Mark has held a National Institute of Health Research School for Social Care Research Fellowship, has been a researcher on the NIHR funded Heads Together project, is a trustee of the Brain Injury Social Work Group and an Honorary Assistant Professor in the School of Sociology & Social Policy (University of Nottingham), he supervises master's and PhD students who are researching brain injury related issues.

Mark is the parent to two adult children, a somewhat inappropriately swearsy uncle to a number of others, and in his spare time volunteers as a dog walker at his local rescue centre for homeless and abused dogs.

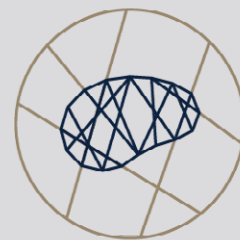
