**09:30 – 09:45** **Understanding Complex Family Dynamics in Brain Injury Rehabilitation**

This session will explore the case of a young person with an acquired brain injury (ABI), navigating recovery within a multicultural family setting alongside three siblings. Parental struggles in setting boundaries—exacerbated by their own trauma history and a sibling's learning disability—contribute to ongoing challenges in behaviour management.

**Key Challenges:**

- Social isolation and loss of structure due to absence from education.
- Medical risks linked to diabetes and weight concerns.
- Severe emotional regulation difficulties, resulting in violent outbursts that jeopardise family safety.
- Increased sexual exploration and disinhibition, raising concerns about vulnerability and safeguarding.

**Discussion Points:**

- Strategies for reintroducing structure and social engagement.
- Holistic health interventions addressing medical and emotional needs.
- Trauma-informed approaches to boundary-setting and behaviour management.
- Safeguarding measures for vulnerable young people navigating increased impulsivity.
- This session will provide insights into multidisciplinary approaches that balance psychological safety, family support, and specialist interventions for ABI rehabilitation.

**09:45 – 10:30** **The Hats We Wear: The Role of Psychology in Complex Rehabilitation Systems**

Working with individuals who have complex needs, along with the extensive family and professional systems surrounding them, requires effective communication, clarity of direction, and emotional containment. This applies equally (if not more) to the clinical team, as well as to the client and their family.

This presentation will outline how different aspects of the (neuro)psychologist's role can assist teams in navigating these multifaceted dynamics. The speaker will introduce some underpinning theory and considerations, as well as practical tips and strategies for managing the inevitable breakdowns and ruptures that frequently occur in the process, using a case presentation as a framework. Topics will include the use of formulation to help make sense of people's stories; the question of "Which hat am I wearing today?" to explore the importance of understanding and managing professional boundaries; the value of taking risks and why doing so can be just as important as managing them; and finally, attention to emotional needs, including the often under-recognised role of play in supporting psychological wellbeing.

**Case Management & Independent Social Work: Reflecting on Practice & Preventing Safeguarding Escalation**

In complex family situations, the roles of case managers and independent social workers are pivotal in delivering the right support at the right time—and in preventing safeguarding issues from escalating unnecessarily. This session uses a live case study to reflect on current case management practices and consider how we can recognise when enough has been done, or where gaps remain. We will explore the unique contribution of the independent social worker in assessing family dynamics and mitigating risk, and examine how targeted parenting assessments and support can enhance family capacity and reduce the need for formal safeguarding proceedings. Attention will also be given to how culturally sensitive, needs-led strategies can be integrated into effective support plans, and how to work collaboratively with statutory services to ensure timely and appropriate intervention.

**The Financial Tightrope: Balancing Legal, Financial, and Welfare Needs in Complex Family Systems**

This session will explore the role of a financial deputy in complex cases, highlighting the transition families often experience as they shift from being primary decision-makers to working alongside a deputy. It will examine what types of support and services can be funded, along with the key criteria used to assess and approve financial decisions. The session will also address the deputy's involvement in welfare-related matters, focusing on how financial oversight intersects with safeguarding responsibilities and considerations around quality of life. Accommodation issues will be explored, particularly in situations where the client owns the property but family members are living in it. Finally, the session will emphasise the value of collaborative working between deputies, case managers, and families to ensure holistic and needs-led decision-making.
